As you may be aware, the City Council is seeking to dispose of Bramham House on the open market shortly in accordance with an approved Planning and Development Brief.

The extent of the land to be sold is shown on plan I attached. It is envisaged that vehicular access will be off Freely Lane and highways improvements will be necessary to support any proposed development. Pursuant to an Agreement dated 14 February 1974 between 1) Leeds City Council and 2) Bramham Parish Council in respect of the recreation land shown on plan 2 attached, under the terms of the Agreement, the Parish Council agreed to dedicate to the City Council, land adjoining Freely Lane, Bramham for future road improvements.

From plan 2 you will note a new footpath link has been provided at points AB, to service the proposed development and has been continued in the opposite side of the road, as shown marked CD on the plan.
